

## Checklist of Legal Documents Required for a Limited (“Ltd”) Company – Corporate

### If the Applicant is a registered Corporate Person

The following documents (notarized and/or legalized as indicated) are required from the applicant before a License can be issued:

9	Memorandum and Articles of Association of the proposed Ltd Company notarized and legalized. <input type="checkbox"/>	
10	Signed copy of the Personnel Sponsorship Agreement (PSA) and Certificate of an Authorization for Government Services (GS) <input type="checkbox"/>	
11	<p>Package Fees and Security Deposit.</p> <p>Payments are to be made in favor of Abu Dhabi Ports Company through a demand draft / cheque / cash / credit card. <input type="checkbox"/></p>	

### Important Notes:

- All legal documents more than one page has to be sealed.
- Powers of Attorney need to be accompanied with a valid passport copy of the Attorney.
- ADFZ Authority reserves the right to call for any extra documents it may deem require, as and when necessary.
- ADFZ Authority reserves the right to ask for extra attestation by the UAE Embassy or other Embassies, as may be necessary.
- Board Resolution and/or Power of Attorney for the Manager must state the Manager's full name as per passport including nationality and valid passport number.
- The legal documents must be in English and / or Arabic. Documents in any other language must be accompanied by a certified English or Arabic translation.
